 Commission Adopts Statewide and Small Urban and Rural Portion of the Program December 2-3, 2020

Commission Adopts MPO Selected Projects May 2021



ATP Cycle 5 Program Years

Cycle 5 will have 4 program years

• 2021-22, 2022-23, 2023-24, and 2024-5

- Enough for a simple project, but may be challenging for a large, complex project.
 - Consider applying for PA/ED and PSE only for projects over \$7 million total costs with extensive ROW needs, railroad or Army Corps of Engineers, etc. involvement.



ATP Allocation Request

Use the Preparation Schedule to Plan

- Meeting Schedule and Deadlines are Similar each Year
- When is the next CTC Meeting? See "CTC Meeting Calendar Dates"
- When is my allocation request deadline? See "CTC Meeting Preparation Schedule" and add one week for Metro review
- Is my allocation request on the CTC meeting agenda? See "Estimated Timed Agenda"
- Can I watch the CTC Meeting without attending? See "Live Webcasts of the CTC Meetings"

What's Involved in an Allocation Request

<u>Demonstrating completion of previous phase(s)</u>

- PA&ED, PS&E, Right of Way, Construction
- <u>Supporting Documents</u>
- Allocation submittal and Obligation RFA federal funded

What Can Hold up an Allocation Request

- Project applications found to not meet PSR equivalency
- Operation and Maintenance Agreements with Railroads or other Cities
- Baseline Agreements
 - Required for projects with total cost of \$25 Million or total ATP programmed fund over \$10 Million.
 - Required prior to all allocations except PA/ED
 - CTC approves baseline agreements within 4 months after project adopted into ATP.
 - If project not yet environmentally cleared, baseline agreement approved within six months after Lead Agency files NOE or NOD per CEQA.
 - Delays to baseline agreement have consequences delayed allocation or project deletion.

Project Delivery Rules of the Game

Timely Use of Funds – Allocation

- Each allocation must be requested in the FY the Phase is programmed
- Construction Allocation is valid for six months to award
- Covid-19 is valid for twelve months with justification
- Programmed funds not allocated within the FY or within the time extension approval, project will be deleted from ATP.

What Happens if Things Don't Go as Planned

Project Delivery Deadline Extensions

- There are separate deadlines for Allocations, Contract Award, Expenditures and Project Completion, and for each phase.
- But only one extension for each of the above
- Submit request to Caltrans prior to the deadline to be extended
- Caltrans will review and analyze the proposed extension request and recommend to Commission for Action.
- ATP maximum extension is 12 months, or 20 if there are Extraordinary Circumstances regarding allocation only.



What if Things Don't Go as Planned....more

Funding Distribution Changes - moving funds between phases

- May request to move fund amounts between PA&ED, PS&E, Right of Way, and Construction
- Cannot move funds out of Construction
- Cannot request if the program year the funds are in has already started
- A funding distribution change can ONLY be requested once during the LIFE of the project – after environmental is complete
- Schedule changes moving funding between years will not be considered



What if Things Really Don't Go as Planned

Scope Changes – a lengthy and uncertain process

- Caltrans can recommend minor scope change; if CTC staff approves, CTC approves as part of allocation request
- if CTC staff denies, can resubmit as major scope change
- CTC staff unlikely to recommend if rescoped project will have reduced benefits

State-only Funding

State-only Funded projects are faster to deliver

- No e-76 (obligation) required
- Procurement requirements are simpler
- CEQA simpler than NEPA
- ROW Self-Certification



State-only Funding...more

Smaller Projects

NI and Plan Projects

 All Quick – Build Project will be designated for State only Funding

MPO has discretion for State-Only Funding recommendation



State-only Funding...more

State-only Funding is Harder to Come by

- Projects must be Federal-Aid Eligible unless designated as "State Only Funded" at the time of Programming.
- Projects awarded as part of Statewide competitions with capital construction cost values of \$1,000,000 must maintain federal eligibility.
- Local Agencies may request State only Funding at time of application but it is not guaranteed.
- MPO can designate projects for State only funding; Metro generally recommends SCAG follow federal aid policy as well.
- All Programmed Quick-Build Projects will be designated for State only Funding

Choosing between Fiscal Years

With ATP it's OK to err on the side of a later year

- Tools to get started earlier than program year
 - ➤ Advance Allocation CTC allocates project one or more years early
 - ➤ Letter of No Prejudice (LONP) CTC approval allows the agency to begin work and incur eligible expenses prior to allocation.
- HSIP also generally facilitates early obligation



Project Cost Estimation

Cost Estimates

Compare with recent similar project cost and schedule

Programming

- Project using Design-Build or Design-Sequencing Contract Method, Construction Phase may include costs for Design and Right of Way.
- No Cost increases will be funded.



Project Cost Estimation

Compare Latest Market with own institution cost and calendar

Compare to similar funded Plan; NI or Infrastructure applications

GENERAL LESSONS LEARNED

- Community Engagement and Buy-Off
 - Affected neighborhoods
 - Affected businesses
 - Community groups
- Alignment with other funding sources (for example, local funds, STIP)
- Alignment with school years for NI projects

LESSONS LEARNED - PA&ED

- PA&ED (Project Approval and Environmental Documents)
 - Not enough time allotted for technical studies
 - Cultural
 - Biological
 - Historical
 - Not enough time allotted for regulatory clearances. Examples:
 - Army Corps of Engineers
 - Department of Fish and Wildlife
 - Water Resources Control Board
 - California Coastal Commission
 - Etc.







LESSONS LEARNED - PS&E & ROW

- PS&E (Plans, Specifications, and Estimate)
 - Underestimating the complexity of the project
 - Coordination with projects in the vicinity
 - Drainage considerations
- ROW (Right of Way)
 - Railroad involvement and coordination (estimate how long and multiply by 2)
 - Overlooked utility relocation efforts
 - Overlooked ROWacquisition
 - Temporary Construction Easements
 - Encroachment Permits (projects encroaching on state ROW)
 - Drainage



PREPARING FOR ALLOCATIONS

- CTC meetings occur 7 times per year
- Agencies need to submit their allocation requests 60 days prior to the upcoming CTC meeting
