Introduction

The Los Angeles County Metropolitan Transportation Authority (Metro) and California Department of Transportation (Caltrans) District 7 initiated the I-710 South Corridor Task Force (710 Task Force) to develop a community-supported, regionally significant, multimodal approach to addressing major mobility, safety, air quality, and equity needs for moving people and goods through the I-710 South Corridor between the Ports of Los Angeles and Long Beach and State Route 60. The 710 Task Force will review and assess the purpose and need for investment in the I-710 corridor, develop multimodal improvement strategies, identify programs and projects to advance these strategies, create an investment and implementation plan, and provide recommendations to the Metro Board in 2023.

The 710 Task Force Meeting #11 was held virtually on Monday, August 8, 2022, on Zoom. The intent of this meeting was to:

- (1) Complete the Vision & Goals Consensus Checkpoint in preparation for Metro CEO to report back to Metro Board in September
- (2) Discuss other items related to the Task Force activities as required by the Metro Board Motion
- (3) Introduce the Multimodal Strategies, Projects & Programs (MSPP) phase and related public engagement
- (4) Present updates from Task Force Working Groups, Committees, and the Project Team

A graphic illustrator visually captured key themes and meeting highlights (<u>Appendix A</u>). Simultaneous interpretation in Spanish, Tagalog, and Khmer was provided. Prior to the meeting, the 710 Task Force received the agenda (<u>Appendix B</u>), presentation (<u>Appendix E</u>), and meeting materials (<u>Appendix C</u>-<u>D</u>).

710 Task Force #11 Virtual Meeting

1. Welcome, Introductions, Agenda Review, and Meeting Objectives, Attendance

- > Erika Morales opened the meeting and reminded attendees that all project materials can be found on the Metro website at https://www.metro.net/projects/i-710-corridor/#documents
- > Ms. Morales conducted the roll call attendance. 25 Task Force members and 3 ex-officio members were present. 29 members of the public were also present.

2. Agenda Item #1: Building a Shared Understanding: Equity

- > To build a shared understanding of equity, KeAndra Cylear-Dodds provided an overview of Metro's approaches to focusing onequity to eliminate disparities between groups and improve outcomes.
- > Ms. Cylear-Dodds shared an overview of disparity-based and targeted universalism equity approaches and detailed definitions of equity. Metro defines Equity as, "both an outcome and a process to address disparities to ensure fair and just access to opportunities."
- > Ms. Cylear-Dodds emphasized that an equitable process depends on whose voices are included, how decisions are made, and trust building. If we are truly striving for equitable outcomes in this process, we must be willing to listen to the communities impacted by the recommendations.
- > Ms. Cylear-Dodds invited the Task Force to consider existing and new projects and programs that will maximize positive benefits, especially for those most impacted by pollution and traffic in the corridor.
- > Ms. Morales invited Task Force members to engage in a discussion about Equity.
- > Task Force comments included:
 - If we overlook the disparities and different types of equity, they will be overlooked by the public.
 - For a project to truly be equitable it must educate and involve engage disadvantaged community members. s.
 - Community members need to be more involved in the decision-making process.

3. Agenda Item #2: I-710 South Corridor Proposed Draft Guiding Principles, Vision Statement & Goals

2.1 Guiding Principles, Vision Statement, and Goals recap

- > Michael Cano provided a recap on the approved Guiding Principles Vision Statement, and the "Air Quality", "Mobility", "Community" and "Environment" goals.
- > Task Force Members did not reach a consensus on the "Safety" and "Economy" Goals at the last meeting.

- > Today's meeting includes further discussion on these goals. "Safety" Goal Test for Consensus
- > Ms. Morales facilitated the Test for Consensus vote for the goal, "Safety".
- > The results were, 12 (53%) voted "I Support", 7 (30%) voted "I can Live With", 4 (17%) voted "I Have Concerns", and 0 voted "I Will Stand Aside"
- > All voting results are available in **Appendix D.**
- > Ms. Morales invited Task Force members to engage in a discussion about "Safety".
- > Task Force Comments included:
 - Including the term "user" or "stakeholders" in the language for the "Safety" goal.
 - Changing language to increase safety for all users along the corridor.
 - Ensuring that these goals meet the regional and federal needs of the corridor.

Roll Call Vote

- > Ghirlandi Guidetti made the motion to approve the original language in the "Safety" goal. The motion was seconded by Natalia Ospina.
- > Task Force members proceeded into a roll call vote on the motion resulting in 17 (77%) Yes and 5 (23%) No. The motion passed.
- > All voting results are available in **Appendix D**.

"Economy" Goal – Test for Consensus

- > Ms. Morales facilitated the Test for Consensus vote for the goal, "Economy".
- > The results were, 6 (25%) voted "I Support", 8 (33%) voted "I can Live With", 6 (25%) voted "I Have Concerns", and 4 (17%) voted "I Will Stand Aside"
- > Test for consensus results are available in Appendix D.

- > Ms. Morales invited Task Force members to engage in a discussion about "Economy" and then proceeded into public comment.
- > Task Force Comments included:
 - A possible addition of two new goals titled: "Prosperity" and "Opportunity"
 - The task force must focus on creating goals to help preserve the communities across the corridor
 - Local economic goals for all marginalized stakeholders must be taken into consideration in the language for this goal
- > Detailed comments are available in **Appendix C**.

Roll Call Vote

- > Task Force Member Dr. Genevieve Giuliano made a motion to vote to rename the "Economy" goal to "Opportunity" and to replace "Foster" with "Increase" in the goal language and introduce the "Prosperity" goal. This motion was seconded by Task Force Member Luke Klipp.
 - The proposed "Opportunity" goal language is: "Opportunity" Increase community access to quality jobs, workforce development, and economic opportunities.
 - The "Prosperity" goal will address the region, and the process will include developing the draft language (in a shared Google document), sending it to the CLC for review on 8/18/22, and coming back to the Task Force on 9/12/22.
- > Task Force members proceeded into a roll call vote to approve the" Opportunity" goal "resulting in 15 (63%) Yes votes and 7 (29%) No votes. The motion passed.
- > All voting results are available in **Appendix D.**

4. Agenda Item #3: Pre-Investment Plan Opportunity Information Item

- Mr. Cano provided an overview of the Pre-Investment Plan Opportunity process and the next steps in the project timeline.
- Ms. Morales invited Task Force members to engage in a discussion about the Pre-Investment Plan Opportunity process and then proceeded into public comment.
- Task Force Comments included:
- Prioritize projects that align with the interests of the CLC and Equity working groups
- Ensuring all projects are presented to the Board for possible grant funding
- Commit to an increase in workforce development across the corridor

5. Agenda Item #4: I-710 South Corridor Name Change Poll

- Ernesto Chaves shared an update on the project name change poll, administered online from July 8 through August 2, 2022.
- The name change poll asked: Please rank the five proposed names below according to your preference, with 1 being your favorite and 5 being your least favorite.
 - o Re-Connecting Communities: The Southeast LA Mobility Investment Plan
 - o The San Pedro Bay to East LA Future Mobility Investment Plan
 - The Long Beach East LA Corridor Mobility Investment Plan
 - My Gateway Community Investment Plan
 - Let's Clear the Air: A Mobility Investment Plan
- There were 524 poll responses. Of the 5 options-the top 3 ranked options were:
 - 1. The Long Beach/East LA Corridor Mobility Investment Plan
 - 2. Reconnecting Communities: The Southeast LA Mobility Investment Plan, and
 - 3. The San Pedro Bay to East LA Future Mobility Investment Plan.

- > Ms. Morales invited Task Force members to engage in a discussion about the project name change and then proceeded into public comment.

Roll Call Vote

- > Ms. Morales facilitated the roll call vote for Task Force members to pick their preference amongst the top three ranked public choices The results were:
 - 15 (63%) voted for The Long Beach/East LA Corridor Mobility Investment Plan
 - 7 (29%) voted for Reconnecting Communities: The Southeast LA Mobility Investment Plan, and
 - 2 (8%) voted for The San Pedro Bay to East LA Future Mobility Investment Plan.
- > Metro staff will share the results of the Public Poll and the Task Force vote with the Metro Board in September.
